

## Southeastern Newfoundland Club – Rescue Rescue Placement Agreement

**Please read carefully. This is intended to be a legally binding document.**

### Name of dog (Description of dog)

**The Southeastern Newfoundland Club is a non-profit organization recognized by the Newfoundland Club of America to do all in its power to protect and advance the interests of the Newfoundland dogs.**

A Newfoundland should not be acquired casually or disposed of lightly but sometimes an owner's circumstances change and the Newf is found to be unsuited to his/her present home. It is on rare occasions that we try to find a permanent home where the Newfoundland will be loved and respected for its unique combinations of qualities.

Please review the following conditions, which SENC Rescue has developed for placement homes:

1. Your home should provide a safe environment, which complies with local ordinances, and adequate shelter from the cold and hot weather. A Newf must **NEVER** be allowed to run loose and should "always" carry ID tags.
2. Even if the Newf is trained, a refresher Obedience course is urged to establish a more rapid respect and rapport between you and your dog
3. **If you can no longer keep this dog, you MUST contact SENC Rescue! You may NOT turn this dog over to any one else!**
4. The adoption fee is **\$380.00**, payable to SENC, and SENC Rescue and others working for and/or associated with the Club shall not be responsible for any damage or injury caused by a Newfoundland placed through SENC Rescue. This includes, but is not limited to, dog bites to persons or animals, or property damage.

The Undersigned has read, understands and agrees to the conditions set forth and hereby further agrees that if the terms and conditions of the Agreement are not upheld by the undersigned and/or if any misrepresentations have been made to SENC Rescue, the Club reserves the right to terminate this Agreement and the dog **MUST** be returned to SENC Rescue. Should it become necessary for the Club to take legal action to recover the Newfoundland or otherwise enforce the provisions of the Agreement, the Undersigned agrees to pay all court costs and reasonable attorney's fees.
